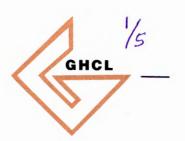

In this regard, the Company got final Listing & Trading approval for said 5.85 lakhs equity shares from BSE Limited vide their letter dated June 19, 2018 (effective from June 20, 2018) and from NSE vide their letter dated June 19, 2018 (effective from June 20, 2018). Pursuant to above allotment of 5.85 lakhs Equity Shares, the Issued & Paid-up Capital of the Company stands increased from Rs. 97,42,32,860/- consisting of 9,74,23,286 equity shares of Rs. 10/- each to Rs. 98,00,82,860/- consisting of 9,80,08,286 equity shares of Rs. 10/- each.
